## **USA EAGLES TOURS (USAET) - CONDITIONS OF BOOKING**

### **RESPONSIBILITY**

USA Eagles Tours (USAET), (which expression shall for the purpose of these conditions include any parent, subsidiary, affiliate or associated company and hereinafter shall be collectively called "the Company") acts only as agents for the hotels, airlines, bus or car companies, railroads, steamship lines, and owners or contractors providing accommodation, transportation or other services, and all coupons, exchange orders, receipts, contacts and tickets issued by the Company are issued subject to any and all tariffs, terms and conditions under which any such accommodation, transportation or any other services whatsoever are provided by such hotels, airlines, bus or car companies, railroads, steamship lines or owners or contractors. The Company shall not be liable or responsible for any loss or damage to any person including but not limited to death of or injury to any person or loss of or damage to any property or otherwise (including baggage) whether due to its servants', agents' or employees' negligence or otherwise arising out of or in connection with any accommodation, transportation or other services or resulting directly or indirectly from acts of God, dangers incident to the sea, hijack, fire, breakdown in machinery or equipment, acts of governments or other authorities, de jure or de facto, wars, whether declared or not, hostilities, civil disturbances, strikes, riots, thefts, pilferage, epidemics, quarantines, medical or customs regulations delays or cancellations of or changes in itinerary or schedules or overbookings or defaults, or from any causes beyond the Company's control or through the acts of default of the hotels, airlines, bus or car companies, railroads, steamship lines or owners or contractors providing accommodation, transportation or other services. The Company shall not be responsible for any loss or damage resulting from improper or insufficient passports, visas or other documents. Neither the Company nor its servants, agents or employees shall be or become liable or responsible for any additional expenses or liability sustained or incurred by the tour members as a result of any of the foregoing causes. All prices quoted are subject to change without notice due to unforeseen circumstances, foreign exchange fluctuations and variations in any or all operating costs. Unused services cannot be refunded or exchanged. The Company reserves the right to cancel the tour and/or modify the itineraries in any way it thinks desirable and further reserves the right to decline to accept any person on any tour and may substitute hotels where necessary. The issuance and acceptance of receipts, tickets, vouchers, coupons or travel orders shall be deemed consent to the above. USA Eagles Tours (USAET) is a DBA of KJA Inc., a California Corporation.

## IMPORTANT INFORMATION

**Tour Prices:** Tour costs shown are subject to alteration due to exchange rate fluctuations and increases in any cost that may arise prior to departure. Costs will also depend on availability of hotels. Tour prices are sold as a complete package. Alterations and deviations during the tour itinerary will not be accepted.

**Reservations and Payments:** Full payment for each Travel Module, for all travelers, is required along with the correctly completed and submitted booking form, at the time of each initial booking. At the same time, you submit payment for each specific Travel Module, you must also pay in full, for any RWC 2023 France match tickets associated with the Travel Module that you elect to purchase. **Both the full payment for each Travel Module, and the payment for the associated match ticket/s are non-refundable.**

### **Cancellation penalties:**

All payments to USAET, including all payments for RWC France 2023 match tickets are non-refundable. After commencement of travel no refunds under any circumstances. It is imperative that comprehensive travel insurance is taken at the time of booking. Besides covering such items as medical and loss of baggage during the tour, policies can cover loss of deposit if you are forced cancel due to any of the reasons covered in the policy you chose. Purchase of appropriate Travel Insurance Protection is not provided by USAET and is the sole responsibility of the traveler ([Travel Insurance Protection](#)).

USA Eagles Tours reserve the right to cancel any Module at any time prior to departure. If this does happen, you will either be offered a place on an alternative Module or if this is not suitable for you, then a full refund will be given.

**Documentation:** All passengers require a passport with minimum 6 months validity from your return date to North America. Compliance with visa requirements is the passenger's own responsibility. Please ensure all names provided to us are exactly as they appear on the passenger's passports.

**Match Tickets:** Unless specified at a later date, all match tickets will be distributed upon arrival in the France. This is for security reasons.

**Baggage:** Baggage is the sole responsibility of the passenger at all times ([Travel Insurance Protection](#) is strongly recommended).

**Travel Insurance Protection:** Travel insurance is strongly advised for all tour members. Documentation detailing a coverage option is available from USA Eagles Tours preferred insurer and will be forwarded to you on request.

**Accommodation:** Most accommodations in France differ greatly from those in North America. Rooms are often smaller, and buildings are often older. When mentioned, **Budget**, **Preferred**, **Luxury** and **HQ** are terms used by USA Eagles Tours solely to describe overnight accommodation for our Rugby World Cup France 2023 Modules only. These USAET accommodation designations do not relate directly or indirectly to any official or unofficial accommodation grading criteria in the USA, Canada, Mexico or France.

**Airlines:** All airline transportation and any associated costs are the sole responsibility of the passenger.

**Transportation within France:** Transportation included in each specific Module, utilizes scheduled, public rail and/or bus services unless specifically mentioned (Read carefully what transport is included in each Module). USAET reserves the right to substitute alternative modes of transport if we deem it to be in the best interests of the tour. These alternatives may be, but are not limited to, minivan, taxi or any other scheduled and/or unscheduled public or private modes of transport.

**Tour Inclusions:** Each Travel Module includes only those items specifically mentioned on this USA Eagles Tours website.

**Exclusions:** Excluded from the cost of these packages are, but not limited to, costs of passports, including renewals, visa's, meals unless specifically mentioned, optional excursions, alcoholic beverages and soft drinks, laundry, dry cleaning, baggage costs, Travel Insurance Protection and any and all items of a personal nature not specifically mentioned in the Modules and inclusions. Discretionary tips, airfares, airport taxes and fees, French, US and Canadian transportation taxes, security and customs fees are not included.

**Travel Advisories:**
